4. Details of our assessment

03/10/24

10:45 - 11:45.

Environment Officer Callum Murray carried out a compliance inspection on the HEP scheme on the Nant Saerbren, Treherbert. The weather was dry and mild.

At the intake location of the HEP scheme, I checked the NGR and drawings attached to the permit numbers WA/057/0024/004 & 007. Dimensions of the weir, HOF notch and pipe diameters matched the drawings.



There was a build up of sediment and gravels behind the HOF notch on the weir. This could cause a negative environmental impact during medium and low flows, as the sediment build up reduces flow through the notch, instead directing more over the screen side of the weir, and through the abstraction point. This can result in lower flows downstream. This will be recorded as a non-compliance with the licence conditions with an action to clear the silt and gravel build up by 07/11/24. A plan should be put in place to regularly monitor the abstraction point to prevent the build up of sediment and remove all debris behind the weir.



Action:

- Clear the gravel build up from behind the HOF notch (by **07/11/24**) and continue regular monitoring to prevent build up occurring in the future.
