### 4. Details of our assessment

#### Schedule 5 Notification 7<sup>th</sup> February 2024.

On the 7<sup>th</sup> February 2024, a schedule 5 notification was received from the operator. The schedule 5 notification was related to biogas release which occurred at digester 1.

The release was discussed in compliance assessment report CAR\_NRW0044756 which was sent to the operator on the 17<sup>th</sup> July 2024.

A required action for the operator was to submit part B of the notification. Part B of the schedule 5 notification was received on the 19<sup>th</sup> July 2024

Part B of the notification stated that the following actions have been or are being implemented by the operator

*“Actions taken and reasons behind.*

- *Reduction in overall gas storage on site.*

*Gas bags were operated at typically operated at 70% operating capacity. Following this gas release normal operating volumes have been reduced to 25-30% so that if another incident occurs the volume of gas released is much lower.*

- *Changed planned maintenance procedures across the business.*

*Now mixing pump maintenance will not happen on both mixing pumps on a single digester on the same day.*

- *Multiplexed more alarms to allow for faster response during a foaming event.*

*Early warnings so foam mitigation steps can be taken earlier to help prevent a gas release.*

- *Planned additional water storage for the foam mitigation system.*

*During a foam and or gas release event the water seal can be lost in the foam mitigation box, water pressure can be reduced. Additional water storage gives added resilience.*

- *Inform NRW of any planned mixer removal events.*

*This was suggested by the NRW officer following a site visit due to the increased probability of odour issues.”*

**Action 1:** Implement all actions above without delay.

**Action 2:** Ensure that all relevant sections of the EMS are updated to reflect any changes in the management of the foam box and gas release systems without delay.

**Action 3:** Submit relevant sections of the environmental management system and any updated operating techniques to NRW for review by the **31<sup>st</sup> October 2024**.
