## 4. Details of our assessment

### Trident Park Operator Monitoring Assessment (OMA) for emissions to air.

An OMA for emissions to air at Viridor's Trident Park waste incineration facility was undertaken on the 16<sup>th</sup> of July 2024. Full details along with recommendations can be read in the attached OMA report.

One area that needs further attention is the weekly evaluation of the validity of the valid calibration range (VCR). Viridor have a requirement in their permit to comply with the requirements of BS EN14181. With regards to the VCR, BS EN14181 states:

*The validity of the valid calibration range shall be evaluated by the plant owner on a weekly basis (Monday to Sunday). A full new calibration (QAL2) shall be performed, reported and implemented within 6 months, if any of the following conditions occur:*

- 1. more than 5 % of the number of AMS measured values calculated over this weekly period (based on standardized calibrated values) are outside the valid calibration range for more than 5 weeks in the period between two AST;*
- 2. more than 40 % of the number of AMS measured values calculated over this weekly period (based on standardized calibrated values) are outside the valid calibration range for one or more weeks.*

During the OMA it became evident that the above assessments weren't being undertaken. Therefore, going forward Viridor will need to incorporate this validity check into their standard operating procedures to comply with BS EN 14181.

**Action 1:** Since it was evident during the OMA audit that these checks weren't being undertaken, NRW request that you review your 2024 CEMs data to ascertain whether the thresholds in checks 1 and 2, in BS EN 141811 (copied above), have been exceeded. **Due 31<sup>st</sup> December 2024.**
