Table S4.1 Leachate level limits and monitoring requirements require leachate levels in monitoring wells below 2m.

The Schedule report of permit breach for leachate dated 02-10-2024 at 2.64m, shows this is over the 2m permit limit. The score for this breach is a CCS3 minor breach.

ACTION: Please ensure access to leachate wells and functionality is maintained at all times, continue pumping. Re-measure and report leachate head in 14 days time.
