4. Details of our assessment

OSM sample taken on 2/9/24 resulted in an ammoniacal nitrogen exceedance which was then notified to NRW on 9/9/24. The ammoniacal nitrogen exceedance result was 8.32mg/l (permit limit is 6.5mg/l) which was the first such failure in the last 12 months and within the allowable number of exceedances, so not classed a failure.

On 1/10/24 DCWW provided detail of the follow up investigation into this result -

Not all sample failures are as clear cut as others and we needed to investigate a bit more with this one. Site was compliant when visited by my team before and after the sample

failure without any intervention, data suggests that flows were in excess of FPF and that we often see a high crude ammonia level, we believe the reduced biological treatment time caused by hydraulic overload on this occasion was just sufficient to cause a slightly out of compliance result. We have seen increases in the past but remaining compliant, on this occasion despite the wet weather the crude may have remained strong causing the sample to fail. We are looking at improved inlet flow control to prevent this from recurring.
