Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

### 4. Details of our assessment

CARS form generated following samples which displayed high results for Escherichia coli (E. coli) of 39,000 CFU/100ml and also Intestinal Enterococci (IE) which was 15,000 CFU/100ml.

The high E coli results and high IE (Enterococcus) results are linked to an un-permitted

discharge into the watercourse via a black pipe located at SH 43727 36816. Please see the picture below.

Bourne Leisure Ltd, Hafan y Mor must ensure that all discharges from the site are via the permitted discharge point located at national grid reference SH 44404 35985.

Separately a regulation 36 notice will be sent out as well.
