4. Details of our assessment

This report is issued in response to an incident reported to NRW via WATPOL on the 23 August 2024 - WIRS ref 2411817

Permit version in effect - 01/05/2020

Information in this report has been gathered from relevant OPNOTS, 10 day pollution report (Dwr Cymru) and e-mail correspondence.

On the 22 August 2024 Quay Road SPS experienced a power outage due to a high voltage failure on the National Grid network. Power at site was lost at approx. 18:30 and was reinstated at approx. 23:00

In the event of a power failure, on site standby power generators are set to automatically start. This did not occur and a spill occurred between 23:44 to 00:13

As stated in the 10 day storyboard, supplied to NRW on the 5 September 2024:

“manually put the generator on as well as close the generator ACB on the MCC. This highlighted that the changeover sequence from the main ACB to the generator ACB has a fault”

The Pumping Station Key Protection Measures document - Version 1 (24/09/24), supplied to NRW on the 30/09/24 as required by permit condition 2.3.1 states:

Permanent standby generator installed and maintained in good working order and activated as soon as reasonably practicable in the event of an electrical power failure.

Standby power generators are installed on site and systems are designed to start automatically in the event of a grid failure, as per PSKPM v1 - 24/09/24. This did not occur and operators had to manually switch this supply on.

As such the spill occurred due to a site operating techniques not working as designed.
