Officers were accompanied around the site by Stephen Thomas, Les Davies and David MacKay. The main reason for the visit was to follow up on actions identified in previous CAR (ref: NRW0033757).

General Observations:

The site was better organised than the previous visit. There was good segregation of waste types and the site appeared to be well managed.

Waste segregation:

On our last visit we highlighted that there was no segregation between the ELV waste, Waste Electronic and Electrical Equipment (WEE) and scrap stored under an exemption. This has now been resolved and good segregation of waste types was observed.

Waste Storage:

On our last visit we highlighted that ELV waste liquids were being stored in an unbunded container off the impermeable pad and on 'made ground'. As well as being a breach of your permit, this posed a significant pollution risk. It was good to see the container had now been moved onto the impermeable pad and the wastes within the container are stored in a bunded tank. The position of the tank however is not ideal as there is still potential for any spillages within the container to flow across the pad and contaminate the made ground. This situation needs to be addressed and several options including bunds, relocation of container were discussed.

Please ensure your EMS for the site now reflects the changes you have made to the waste operation including the waste storage location. The EMS may be the focus of our next inspection.
