### **General Management**

During the inspection it was noted that the site was well maintained with no debris, loose waste or litter on the yard. Drains were kept clear and the impermeable surface was in good condition.

### **Waste Storage**

Waste was stored appropriately on the yard within designated skips and concrete bays, all waste was on impermeable surface with appropriate drainage in line with **condition 1.1.1** of the permit. No non permitted waste identified during the inspection,

### **EMS and Permit**

The EMS and Permit were unavailable during the last inspection due to John covering for illness. **1.4.2** of the permit, *'A copy of this licence and the working plan shall be kept available on site for reference when required by all staff carrying out work under the requirements of this licence'*.

The Permit and the EMS were readily available this visit.

Some waste transfer notes were reviewed during the inspection, no issues were identified with these.

### **TCM**

If there are any changes in the technically competent management of the site, please notify me in line with **condition 1.5.1** of the permit.

### **Pollution Prevention Control**

Under **condition 2.1.2** the engineered site containment and drainage systems shall be inspected, validated and maintained. The drainage was blocked on arrival at the site but NRW Officers were made aware that a load of waste was transported off site prior to our inspection and the drain would be cleared the afternoon of the 18/10/2018.
