Unannounced site inspection undertaken by Michael Edwards and Ieuan Davies of NRW, met on site by depot operator Neil.

(C2) Management system and operating procedures

During the previous inspection we noted an issue under **condition 1.1.3** of the permit, as staff members on site were unable to locate the EMS or the environmental permit. *'Any person having duties that are or may be affected by the matters set out in this permit shall have convenient access to a copy of it at or near the place where those duties are carried out'.*

During the most recent inspection the permit and management system were easily obtainable as required by the above condition.

(B3) Site drainage engineering (clean and foul)

No issues were identified with the drainage on site with all drains kept clear of debris and no pooling of water visible during the site inspection.

(B4) Containment of stored materials

All wastes were stored in designated bays during the inspection. However, we have some concerns over the height of the waste soil stored on the yard as it exceeded the height of the bay walls and had the potential to escape from the bay.

Currently processed hardocre is stored outside of the permitted area.

For the processing of the hardocre material brought onto site and then crushed, can you please provide evidence on the QP that is followed and any testing that is undertaken on site so that it ensures the end product meets end of waste criteria.
