4. Details of our assessment

On Thursday the 10th of October 2024 Waste Regulation Officer Ian Thomas carried out a routine unannounced site inspection.

On arrival Ian met with Paul Sleeman, one of the managers from Wrexham Borough Council. He explained that Lee Ellis, the technically competent manager for the site was out visiting another facility. Paul showed me around the site and confirmed that the processing has not changed. The site is receiving 170107 and 170102 which is processed into 6F5 and 40mm stone to be used on council projects.

General Management

The site is a multi-use facility. Parts of the site are used by Wrexham Borough Council for storage of various stock. These include all differing types of building materials, bicycle storage and vehicles/trailers. The site is segregated so that these areas do not impact on the permit.

The area used for the permitted activities was checked and appeared well organised. The finished products are stored in separate bunkers and storage time is minimal.

Environment Management System – EMS

After viewing the site, Paul produced the file containing the EMS and various other safety documents available for staff to view. Waste Transfer notes were checked and were found to be completed correctly. Some of the Waste Transfer Notes were kept to be copied as there are third party companies collecting product from the site, these are being used on separate jobs. As one of the companies are a permitted business, officers want to ensure this process is being followed correctly and under the relevant permit conditions.

I am pleased to report on this occasion no issues were apparent.
