4. Details of our assessment

Withyhedge Landfill

Resources Management (UK) Limited (RML) operates Withyhedge Landfill under the provisions of an EPR Permit (MP3330WP).

The site is a non-hazardous landfill and was constructed in two phases. Phase 1 accepted waste from 1985 until its closure in 2006. Phase 2 is the current operational area, although no waste is presently being accepted at the site.

Introduction

An unannounced site inspection of the landfill was undertaken on 2nd October 2024. The site inspection included observation of Cell 9 construction works, a visit to the surface water management lagoons and gas utilisation plant (GUP).

Odour Assessment

NRW officer undertook an odour assessment prior to attending the landfill site. Assessment was undertaken at locations within the local community, including locations within Spittal, Crundale Poyston Cross and Treffgarne. During the odour assessment weather conditions were dry, overcast, temperature between 12-14°C, with a steady breeze from an East-Northeast direction.

No landfill associated odours were detected offsite during the assessment. Observations and findings recorded on a odour assessment report.

Landfill Engineering

Construction of Cell 9B has been completed and CQA validation report has been issued to NRW for review. Clay base for Cell 9C is now mainly complete, construction of the Basel liner to begin during a period of improved weather conditions.

Clay for the purpose of construction continues to be delivered to site. Clay being stored in the loading bays at the waste transfer station.

Heavy plant being used on the phase 2 surface water management lagoons. D2 discharge point remains unused. Heavy plant also being used to lay stone along the Northern edge of the landfill to improve the road condition.

Operator has erected a fence, consisting of wooden posts and netting along the top of Cell 8 to mitigate against wind-blown litter.

Gas Management System

During the inspection two gas engines were operational along with the emergency flare. Performance data for the flare retrieved by NRW officer. The landfill capping was laid flat with no gas pillowing beneath.

The sites new 2000m³/hr flare has been delivered to site, ductwork and manifold for the

flare have been connected. Flare due to be commissioned in coming weeks.

During the inspection NRW officer did not detect any landfill associated odour on the landfill.
