4. Details of our assessment

This CAR form is being generated as a result of a pollution complaint by a member of the public. From photographs taken at the site, it can be seen that effluent discharges at the top of the beach rather than down the outfall and into the tidal range as required by the permit.

It's noted that there has been e-mail correspondence with Dwr Cymru regarding this outfall in 2022 and 2023 with comments about awaiting AMP funding.

Given that the location of the outfall is specified in the permit for the site, both in terms of the location of the discharge, and specifically around maintaining the outfall, the issue has been scored as two permit breaches. Consequently a warning is being issued.

Please provide a timetable for repairs by the 13th of November. Then please move forwards with repairs. You may need a marine licence from Natural Resources Wales to do this.

Should no action be taken, Natural Resources Wales will consider further enforcement action.
