4. Details of our assessment

Thank you for showing me around the poultry unit to carry out a site inspection and an audit of the paperwork. Your paperwork is in good order, up to date, and has been reviewed annually. The permit variation has now been completed. The only issue noted during this year's visit concerns staff training.

Staff Training Records

Effort has clearly been made to complete all the training for one of the two main operators and bring it up to date, including a recent First Aid training course, however almost all courses are out of date for the second operator. Over the course of the next 12 months efforts must be made to complete training to ensure that staff competency can be maintained and that you are compliant with section 1.1.1(b) of your permit.: -

The operator shall manage and operate the activities.....using sufficient competent persons..

Training should include First Aid; Environmental Awareness, which covers the Environmental Permitting Regulations 2016; Manual Handling; Health & Safety, and Labour Exploitation if this is considered to be relevant, in addition to any training which may be required around the management of the birds.

Action: complete all outstanding training by the end of September 2025.
