I met Terri Shaw and Alan Llewellyn on site. The site has excellent security and is only opened for the delivery or despatch of waste asbestos material. Terri Shaw stated that they have seen a steady drop in the amount of asbestos being fly tipped.

The impermeable pavement had a large amount of vegetation growth from what appeared to be cracks. I discussed the need to clear this away and get the impermeable pavements integrity checked by a suitably qualified engineer.

I also discussed the working plan (EMS) for the permit. There are a number of references within this working plan that have expired or changed. Please ensure that this is reviewed and updated in line with current working practices.

Terri Shaw is the technically competent manager. Her WAMITAB continuing competency is due in November this year. Please forward me the copy of the certificate when you receive it.
