I have inspected this site over the past several years. There have been considerable changes with regards to infrastructure and waste types that are received.

- As stated in the previous CAR form the working plan is over 10 years old and requires updating to reflect current working practices.
- I have also asked for the consent to discharge for the liquid waste being discharged from the dewatering area. I have still not received this information.
- The interceptor maintenance and sampling records have still not been forwarded to me.

There have been considerable improvements to the yard area and a significant amount of inert and other building material stockpiles have been cleared. You have stated that you no longer take gully suckings and now only receive road sweepings.

Can you forward me the last 6 months consignment notes for the various hazardous waste that have been removed from site. Also ensure any old rusty oil drums (stored in the bunded areas) are disposed of via an appropriate contractor.

You have been issued a warning notice which gives you to the 11th of December to ensure the above issues are addressed. Failure to meet these requirements could result in prosecution.
