Officers were accompanied around the site by Stephen Thomas, Les Davies and David MacKay. The main reason for the visit was to follow up on actions identified in previous CAR (ref:NRW0033779) and to discuss the Fire Prevention and Mitigation Plan (FPMP) as requested by David MacKay.

Our previous inspection found that a significant volume of plastic silage wrap was being stored in the middle of the yard and not in accordance with the site's current Fire Mitigation and Prevention Plan (FPMP). This issue has now been resolved. Most of the plastic wrap had been removed from site and the yard was better organised.

TCM for the Site David Mackay asked about the FPMP requirements and enquired if TBS had to follow the guidance as they would struggle to do this due to their constantly changing business environment. I confirmed that if TBS chose not to follow the guidance or appropriate sector specific advice (e.g. Waste Industry Safety and Health Forum (WHISH) - Reducing fire risk at waste management sites) when complying with their FPMP they should ensure that the measures they take are equivalent or superior to this standard, and that they comply with regulatory requirements. I also confirmed that their current FPMP was under review and comment would be sent to them in due course.
