## 4. Details of our assessment

### Compliance of Control of Pollution (Amendment) Act 1989

On Thursday 31<sup>st</sup> October 2024 Andy Prestt, Carriers and Brokers Officer visited M & E Bin Hire Ltd – permit reference SP3495FG checking waste transfer notes, customer waste carrier licenses and site duty of care compliance processes.

#### W1A General Management – C3 breach of permit condition

Your management system must explain how you will comply with the requirements of waste Duty of Care. This includes ensuring any waste carriers you accept waste from are registered.

During our inspection, we noted that your systems to record movements of waste through waste transfer note documentation was good, but identified there were several businesses or waste carriers that did not have waste carriers licenses. As a result, we have scored a breach against this condition. You must ensure your management system includes procedures explaining how you will comply the requirements of Duty of Care and you must operate in line with these procedures,.

To comply with your duty of care requirements you must check waste carrier licenses of all businesses, sole traders and scrap metal collectors transporting waste onto your site.

If a business is not registered as a licensed waste carrier and refuses to do so
