4. Details of our assessment

This Compliance Assessment Report follows the Operators response to Action 4 from CAR NRW0043245: *“The Operator should identify alternative ways and times for the wrecking activities that are undertaken during the annual maintenance outage and provide a proposal to NRW as to how they plan to undertake these activities in the future. A proposal should be submitted to NRW for review by 30th June 2024.”*

An extension for the completion of this action was requested by the Operator in June 2024, and a submission date of the 5th September agreed.

The Operator engaged with their noise consultants to investigate possible noise mitigation measures for the annual maintenance shutdown works scheduled for January 2025. The proposal was received in the agreed timescales and has been reviewed by NRW Officers.

The refractory installation contractors will trial the use of concrete splitters as an alternative tool, however, there is a need to drill into the lining before using the tool and this may cause further offsite noise impacts.

Temporary close fitting acoustic screening around the preheater tower vessels will also be trialled. The use of absorbent panelling within the vessels, although highlighted as a potential option cannot be progressed due to health and safety concerns.

The Operator is also looking at whether it is possible to use alternative linings within the calciner and preheater tower vessels, this would potentially lead to a reduction in the frequency of replacement and potentially reduced noise associated with its removal and replacement in the future.

The Operator is reviewing the programme with their contractors to minimise the amount of wrecking carried out between 23:00 and 07:00, however night-time work will have to occur due to the shutdown time constraints. Alongside this the Operator will consider weather conditions during the works and rearrange some work if possible. The Operator has stated that *“the shutdown plan is complex and is laid out to ensure that works are carried out as safely and efficiently as possible.”*

NRW are satisfied with the proposals suggested and welcome the additional monitoring that will be undertaken by the Operator at offsite sensitive receptors during the different options / trials.

Depending on the success of these trials, further discussions will be had between NRW and the Operator regarding future shutdowns and what could be achieved routinely to reduce off site noise during the annual maintenance shutdown.
