3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

This compliance form was conducted as part of a routine inspection.

NRW staff; Alex Grainger, Charlotte Rhodes, and Kayleigh Miles, arrived at site at 10:00am. The weather was very overcast but mostly dry.

Met with DCWW at the site where they proceeded to lift the manholes to reveal the screens for further inspection. The screens looked to have been in use recently with a lot of rag / debris visible (picture below):



NRW asked DCWW what the frequency in which this site's screens are maintained / checked. DCWW said that it is between 6 monthly - yearly. The last time the screens underwent cleaning / maintenance was 13/08/2024.

According to the DCWW storm overflow map, this site last went into spill on 06/10/2024. DCWW did say that this site suffers more from infiltration / surface water run off than other sites in the area, causing increased load on the asset and therefore higher chance to go into spill.

Although the screen had been cleaned 2 months prior, the condition of the screen during the visit suggests this site might benefit from an increased maintenance / cleaning schedule.

As per section 2.3.2 (b) of the permit for this site which states:

"The discharge shall not be comminuted or macerated and shall have passed through screens as specified and shall not contain a significant quantity of solid matter with a particle size greater than any indicated. All screenings shall be removed from the discharge."

Since the screen shown above has a significant amount of debris on it, it may fail to sufficiently screen any flow passing through, especially if the maintenance frequency is 6 monthly / yearly. and risk a non-compliance.

Therefore, NRW recommend that the frequency of screen maintenance at this site be reviewed to ensure the screens are able to function properly in the event that they are used.
