4. Details of our assessment

On Friday 4th October 2024 NRW received a report from a citizen scientist who had identified a discharge from the shared outfall by Ffrwdgrech Industrial Estate in Brecon, a discharge that had elevated levels of ammonia and phosphate. In response to this incident

I contacted the two main contributors to this outfall, one of which being Beacon Foods.

I received a reply from Edward Gough, Beacon Foods Chairman confirming Beacon Foods had not been discharging since 09:30 on 30/09/2024 so were not liable for any content within this discharge. I have no reason to doubt this therefore any discharge from the aforementioned sampling is not likely to have been caused by Beacon Foods.

However condition 4.3.1 requires Beacon Foods to notify NRW 'without delay' of any 'malfunction, breakdown or failure of equipment' that could cause a pollution or exceedance of permitted limits. Given the subsequent in-house sampling of the final effluent (which was not discharged) was in excess of 200 mg/l for ammonia, had this been discharging it could/would have a significant impact on the watercourse and protected species therein. As a consequence I have scored this CAR form a C2 for potential impact/risk. Because there was no known pollution, I am issuing this CAR form with a Warning rather than considering further enforcement action. However this could change should anything else come to light.

ACTION: Review and improve notification process for informing NRW of any problem/malfunction as described in the permit.
