4. Details of our assessment

This CAR form is being generated as a full investigation report for trigger breaches in January 2023 that should have been delivered by the 31st of July 2024 has not been forwarded to Natural Resources Wales. This was an action required from CAR_NRW0043008.

This CAR form is dated the 1st of August 2024 as this would be the first date after the deadline for the required report.

Please supply the required report by the 11th of November, or further enforcement will be considered.

It's noted in your Initial Investigation Report that detailed root cause analysis, optioneering, solution development and outline design was being worked on by Dwr Cymru and was supposed to have been delivered by the 30th of June 2024. Nothing has been received.

NOTE: To add to the complexity of the trigger breach reporting process, the permit for Benllech STW LSO (long sea outfall) number CG0381901 was consolidated in August this year into permit number CG0326001. Permit CG0381901 was subsequently surrendered. As a consequence, this CAR form is generated against the consolidated permit (CG0326001) and this is the permit number that needs to be quoted from now on.
