4. Details of our assessment

This CAR form is being generated as a full investigation or plan to deal with the trigger breaches that happened in March 2024, that should have been delivered by the 3rd of June 2024, has not been forwarded to Natural Resources Wales. This was an action required from Compliance Assessment Report CAR_NRW0043747.

This CAR form is dated the 4th of June 2024 as this would be the first date after the deadline for the required report.

A verbal update was provided at the Dwr Cymru Technical Surgery on the 12th of September 2024 that the issues with this site had moved forwards to the detailed design stage. However, this has not been confirmed in writing.

Please provide an appropriate report by the 11th of November 2024. Further enforcement will be considered if no report is received.

This CAR form is different to the previous CAR form issued today for this site (CAR_NRW0045449) as that had a different date of non-compliance, so had to be on a different CAR form.
