This was an action required from Compliance Assessment Report CAR_NRW0042999.

This CAR form is dated the 13th of March 2024 as this would be the first date after the deadline for the required report.

A verbal update was provided at the Dwr Cymru Technical Surgery on the 12th of September 2024 that the issues with this site had moved forwards to the detailed design stage. However, this has not been confirmed in writing.

Please provide an appropriate report by the 11th of November 2024. Further enforcement will be considered if no report is received.
