### 4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q3 2024 monitoring returns.

#### **Q3 Monitoring Returns**

The Q3 monitoring returns were received on 15th October 2024 for discharges from W1 and W2 emission points in compliance with permit condition 4.2.3.

Suspended solids were reported as 56mg/l which is above the emission limit value of 50mg/l as detailed in Schedule 3(b), Table S3.2. A Schedule 5, part A notification was received for this breach of emission limit on 3rd October 2024 and part B was submitted on 10th October 2024.

**Score:** (IR3A) Emissions to water, air or land. Permit Condition 3.1.2. Schedule 3(b), Table S3.2. Non-compliance score C3.

Site investigations found that fluctuations in the flow rate through the effluent plant caused high solids. When high solids are detected, the effluent plant control system activates a valve to recirculate the treated effluent. The action limit for recirculation has been lowered.

#### **Action:**

Conduct further root cause investigations into the elevated suspended solids issue. You may want to include utilising suitably qualified personnel for microbiology checks, aeration levels and chemical dosing to optimise the treatment of effluent according to the lower flows into the plant due to the closure of PM1 machine.

The annual priority hazardous substances screen report was received on 15th October

2024 as per permit condition 3.3.1, Schedule 3(b), Table S3.2 for emissions to water.
