4. Details of our assessment

Email received from DCWW on 28 August 2024

We believe the sample failure was flow related. We saw an increase in flows due to rainfall and as the site is on a small network the site does react to increases in flow. This site has no storm consent so it does take all of the incoming flows. The increased flow caused solids carryover into the final effluent sample point for a short period of time.

Please monitor the situation during any high flow events with the view to improving operations should the issue reoccur .

Further update received from DCWW on 18 October 2024

- Following our investigation into this failure it appears that during the period of high flows on the day of the sample failure solids were carried over into the final effluent sample chamber.
- Since the failure we have made a number of improvements to site including;
 - Increased operational site visits
 - Installation of a solids monitor
 - A solids monitor will allow us to monitor the FE via telemetry and be proactive with any emerging issues.
 - Overhaul of SAF and Blower pipework
 - Change in alarm levels.
