4. Details of our assessment

On 19 September 2024 a sample taken at Carew WWTW returned a result for BOD of 50mg/l against a permit limit of 40mg/l.

Please provide a reasoning for this exceedance by Friday 18 October 2024.

Update from DCWW received 18 October 2024

- BOD Sample Exceedance of 50mg/l over a consent of 40mg/l on the 19th September 2024.

- Reduced biological treatment across the process
- Unable to determine the exact cause as there were a few contributing factors
- Comms failure onsite a few days before the failure masking any alarms
- Visited the days before the failure and no issues onsite
- Day of the failure found biofilter 1 has a rotation fail
- Possibility of stronger crude effluent as removed infiltration in the network which could change the loading profile on the works
- Also have issues with saline intrusion getting into the network in high spring tides, there were high tides during the week of the failure and salinity can effect biological treatment.
- Since the failure we have a number of actions to try and mitigate a similar failure happening again, these include;
 - Reviewing the causes of the rotation failure alarms
 - Investigating the saline intrusion by sampling the network in the spring tides
 - Looking into the possibility of upgrading the network to help resolve the comms failures and poor signal
 - Conduct flow and load surveys in wet and dry weather to gain a full understanding of the loading profile on the works
