4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the Q3 2024 monitoring returns (July-September) by Dairy Partners (Cymru Wales) Ltd (the operator) for activities at The Creamery, Aberarad, Newcastle Emlyn SA38 9DQ under Environmental Permit EPR-WP3231NB.

Q3 Monitoring Returns 2024

The monitoring returns in respect of parameters and emission points specified in Schedule 4 Table S4.1 are required to be submitted to NRW within 28 days of the end of the reporting period as required by Condition 4.2.3. The operator submitted the Q3 2024 monitoring returns to NRW on the 9 October 2024 within the specified reporting window as per condition 4.2.3.

Water1 / 01/09/2024 – 30/09/2024

For the period 1 to 30 September 2024, the submission for emissions to water (W1) provided data for the maximum daily discharge volume, Biological Oxygen Demand (BOD), Chemical Oxygen Demand (COD), Total Suspended Solids (TSS), Ammoniacal Nitrogen, Nitrite, Total Nitrogen, Total Phosphorus, Total Aluminium, Temperature, pH and Chloride. All parameters were within the permitted limits.

Emissions out of W2 for visible oil and grease has been declared as clear. W3 is blocked up and should not present any discharge risk.

All monitoring returns were submitted in-line with the permitted requirements. Based on the reports submitted by the operator, the monitoring data submitted is within the compliance parameters specified within the permit.

Dairy Partners have completed the Q3 2024 monitoring in-line with Condition 3.5.1.
