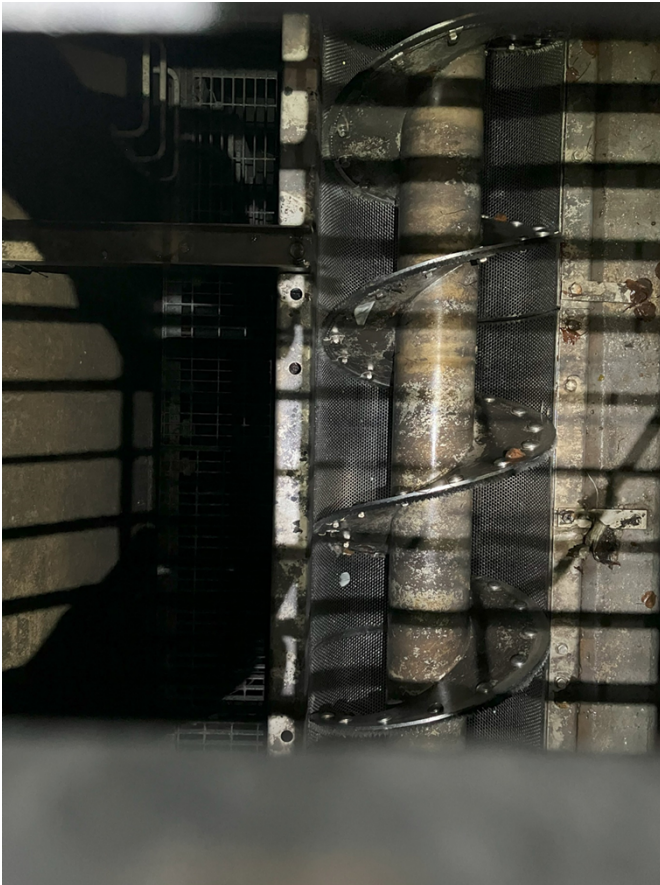
4. Details of our assessment

This compliance report was conducted as part of a routine inspection.

NRW staff; Alex Grainger, Charlotte Rhodes, and Kayleigh Miles, arrived at site at 11:40am. The weather was overcast but mostly dry.

Met with DCWW at site where the entrance to the site was underground due to it being near the Principality Stadium. DCWW opened the access to the pumping station to inspect. NRW did not enter due to this asset being classed as a confined space.

DCWW went to inspect the screens on behalf of NRW, providing the following photos of the screens:



From the pictures taken by DCWW, the screens look to be in good condition, with no visible

signs of debris / rag present. NRW request that DCWW provide the maintenance frequency of the screens at this site.

The on site log book mentioned that on 02/09/2024 that all pumps had failed at this site. NRW request that further information about this failure be provided, as well as spill data around this time also be provided.
