4. Details of our assessment

This report is issued in response to an OSM Failure Report.

Permit version in effect - 26/03/2021

On 17 October 2024 Natural Resources Wales (NRW) were informed via email of an OSM Failure at Afan Waste Water Treatment Works for Free Cyanide. The sample date for this

failure was 25/09/2024.

OSM sampling showed that the final effluent was show to be discharging above the permitted MAX limits for Free Cyanide.
