4. Details of our assessment

Thank you for showing my colleague Rhys Ellis and I around the farm. Overall we were impressed by the operation and the standard of your record-keeping.

Just a couple of minor issues which came up during our visit:

Solid Manure exports

Permit condition 2.3.3 states that:

"The operator shall maintain and implement a system to record the quantities of solid manure or slurry exported from the installation, as defined on the site plan.... The records shall include as a minimum:

- the date of export from the site
- the quantity exported
- details of the receiving site

The details of manure export were not available on the day of inspection. I understand that all manure is exported to your other farm where you have a manure storage facility, from where it is either spread to your own land, or exported on to other farms. Please send through a copy of these records from 1st July 2024 onwards(to cover the last three months) by 15th November to demonstrate that you are complying with this permit condition.

Four Year Review

The 4 year review will be due in July 2025 for energy efficiency, efficient use of raw materials and water, and the avoidance, recovery & disposal of wastes (permit conditions 1.2.1(b); 1.3.1(c), and 1.4.2) I will e-mail you a form which can be used for recording this information. This should be completed and returned to us next summer.

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
