4. Details of our assessment

On Thursday the 17th of October 2024 Natural Resources Wales officers attended site.

This was a routine site inspection which was carried out by Waste Regulation Officer Ian Thomas.

On arrival at site, Ian met with Clive Thomas, site operative who explained how the site was running, and how the loads are recorded.

Waste returns were checked before visiting the site, these were up to date and showed 31744 tonnes received in Q2. No waste removed as all materials are still being used to fill parts of the site. Clive explained

that all loads are approved prior to arrival by Tony Williams, to ensure only accepted materials are being brought to site. All loads are recorded directly on a spreadsheet in the weighbridge office, and copies of Waste transfer notes kept. A list of hauliers with waste carrier licences are displayed inside the office and checks are made to ensure the licences are valid and in date.

Copies of all relevant paperwork for the site was available and looked in good order. The site inspection continued by checking the area where loads are currently being deposited.



The materials look to be inert and not contaminated.

Materials are spread using the plant machinery on the site. On returning to the main entrance weighbridge area, the use of the wheel wash facility was discussed with Clive. Please confirm if the silt from the wheel wash is removed from site as a waste or distributed on site.
