### 4. Details of our assessment

#### Actions Required

River levels in the River Monnow were high when I attended the site, possibly this was the reason I was unable to locate the outfall from the sewage treatment plant. MHA have subsequently confirmed via email:

'We maintain the plant located at Orchard Close in Skenfrith. The plant is a diamond treatment plant and duplex station, and it serves 6 properties. Our latest records indicate

that 18 persons is the total number of people at the 6 properties.

The discharge point is very difficult to find as its past the castle and pretty well hidden on the bank of the River Monnow, but it exists'.

Servicing and uplift records were attached to the email. The service report dated 4/7/24 noted several issues which required attention (yard overgrown, air blower tripped, lamps inoperable). You must ensure that any issues such as these are dealt with in a timely manner and are fixed before the annual servicing occurs.

Condition 4 of the permit states that 'adequate facilities shall be provided at the outfall to enable representative samples of the discharge to be safely and conveniently obtained at any time. It is not clear that the outfall is currently accessible or clearly marked. This must be rectified so that future inspections can take place or samples can be taken, if required.
