4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised following a routine site inspection.

Green waste is weighed on the weighbridge and is then deposited in the waste reception area. This waste is then moved into one of the 6 in-vessel tunnels for processing. Air is forced through the tunnels and the air from this process is discharged through a bio-filter to atmosphere. Once the processing of the waste is complete it is tested to comply with Animal By-Product (ABP) Regulations. Once it has passed the tests, the material is passed through a windsifter to remove any contaminants such as plastics or paper and is then stored inside the building for despatch to another site.

The in-vessel tunnels have 3 temperature probes each which are monitored alongside moisture and oxygen levels to maintain compliance with the PAS 100 quality protocol and ABP Regulations.

New process equipment for the composting activity was being delivered and installed during the visit. The trommel, shredder, screen and windsifter were all being replaced. An addition to the process was a new picking cabin which was viewed during the visit. The site anticipates that all the upgrades to the composting area will be completed by the end of November.

Wastes were still being accepted and stored inside the building on an impermeable surface. Whilst the new equipment is being installed the food waste is being kept separate from the green waste and is being sent off site for anaerobic digestion. Once the new equipment has been installed the usual process will resume where the green waste is mixed with the food waste before being placed in the tunnels. The levels of stored waste was low.

There was a slight transient odour at the building entrances but no odour was detected outside of the site boundary.

The waste transfer part of the permit was viewed. There were 3 outside bays with an impermeable surface where glass, wood and flytipped/litter bin waste was being stored. The glass waste is processed once a year to remove any frames to enable all the glass to be recycled. Flytipped/litter bin waste is transferred to another site for sorting and processing.

Discussions were held on a possible permit variation to increase the throughput limits. Site was advised of the current delays within NRW's permitting queue and the importance of

submitting a variation as soon as possible if the decision is made to increase the throughput limits.
