Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

On the 12th September 2024 you informed us via a Self Report of a burst rising main at Dunvant RFC, with flows entering the nearby watercourse. You told us that Killay Railway Inn SPS had been isolated in order to carry out the repairs to the rising main and that you were managing the flows at the SPS with tankers.

You updated us on the 13th September via the Self Report to say that the repair had been completed on the rising main at Dunvant RFC. You also informed us that the pumps at Killay

Railway Inn SPS were up and running and tankering had ceased but a 4 hour spill had occurred on the 12th September from the Emergency Overflow between 10am-2pm.

The permit for Railway Inn SPS covers discharge in an Emergency as defined in the permit conditions.

The permitted discharge point for the Emergency Overflow is to the Clyne River at SS 59843 92343.

I have assessed if the Emergency discharge was compliant with the following permit conditions and I have concluded that it was.

Compliance with permit condition:

2.1 Permitted activities

2.1.1 The only activities authorised by the permit are the activities specified in schedule 1 table S1.1.

An emergency shall be defined as the period when the sewage pumping station is inoperative as a result of one or more of the following, which is not due to the act or default of the operator, its agents, representatives, officers, employees or servants;

- electrical power failure;
- mechanical breakdown of duty and standby pumps;
- rising main failure;
- blockage of the downstream sewer.

I believe that the discharge from the emergency overflow was as a result of the rising main failure.

Compliance with permit condition:

4.3 Notifications

I believe that you have complied with 4.3.1 as you notified us of the discharge promptly.
