4. Details of our assessment

On 23 August 2024 NRW Officers Sally Wakeford and Katie Lewis-Davies conducted a site inspection at Castle Meadow Closed Landfill EPR/BP3698FP.

On arrival at site we were greeted by a gentleman called Mark who informed officers he was the landowner. That he had purchased the land from the Operator approximately 30 years ago. He was aware of the landfill at the site.

Castle Meadow was a landfill taking non-biodegradable wastes, including soil, subsoil, excavation waste, natural stone and slate and brick. The site is in closure and appears to have been restored. There are no waste activities currently taking place at the site.

The site is vegetated, and used for grazing. No ponding was visible on the site. There is no evidence of vegetation dieback or cracking of the surface to indicate slippage of wastes.

The watercourse around the site was clear and free from any visible contamination.
