Natural Resources Wales Officer Shaun Rees met with site representatives Amanda and Sarah Evans and Will Lea, compliance Manager of Lloyds Animal Feeds on the 28/10/2024 at 10:10am.

Due to the sensitivity of this case, the legal matters out of your control, and the enquiries you have already made i have submitted an ongoing non compliance result - not scored, regarding the name change of the operator and any other permit associated updates.

All other records were complete and in place.

Again, due to the sensitivity of this case the site itself has only just had major building works completed, but still require groundwork improvements around the site and as discussed on the day, these are being looked into by yourselves.
