2.9.1 The limits for the level of leachate listed in schedule 4 table S4.1 shall not be exceeded.

(a) any malfunction, breakdown or failure of equipment or techniques, accident, or fugitive emission which has caused, is causing or may cause significant pollution;

(b) the breach of a limit specified in the permit;

(c) any significant adverse environmental effects.

Schedule 4 – Emissions and monitoring

Table S4.1 Leachate level limits and monitoring requirements require leachate levels in monitoring wells below 2m.

The Schedule report of permit breach for leachate dated 22-10-2024 at 2.96m, shows this is over the 2m permit limit. The score for this breach is a CCS3 minor breach.

ACTION: Please ensure in well pump is adequate for levels encountered and ensure it is serviced and connected at all practically possible times. Part B of the Schedule notification stated the following:

'Pump was disconnected due a pump fault during very heavy rain event (on uncapped area) Pump fault now rectified and pumping resumed'

Please clarify why the pump was initially disconnected and that as for the previous breach access to leachate wells and functionality is maintained at all times. Continue pumping and re-measure and report leachate head in 14 days' time to check for compliance.
