### 4. Details of our assessment

CARS form generated following site visit on the 24/10/24.

Two Environmental officers from Natural Resources Wales met with the Catchment

Operations Manager, the Senior Ops Supervisor and the Pollution Technician from Dwr Cymru.

The Catchment Operations Manager walked us around the site. Showing is the 4mm screens which are then pumped through 1mm screens. The site uses a UV method of treatment creating a Anoxic zone. Discharge point not inspected as it discharges out in Barmouth Bay.

A leak was noted on the Auger that was causing untreated water to pool on the site. Please see Figure 1 below. The site does have integrated drainage but some of the water was escaping to the nearby ground.
