4. Details of our assessment

CARS form generated following site visit on the 24/10/24.

Environmental Officers from Natural Resources Wales met with the Catchment Operations Manager, the Senior Operations supervisor and the Pollution Technician from Dwr Cymru.

The DCWW staff escorted NRW officers around the site. We were shown the primary submerged tanks, the RBC (rotational biological contactor) and the rest of the site. No issues were identified.

Discharge point not inspected as it discharges out into Barmouth Bay.
