4. Details of our assessment

Full Licence To Abstract Water (21/58/61/0036) – Maesteg Golf Club

Site Report

Arrived: 10:10

A compliance visit for the licence was undertaken on 30/10/2024. A Natural Resources Wales environment officer along with the facilities manager and head greenkeeper for the golf club were present. The weather was dry at the time of the visit and 12°C.

When attending the facilities on site the head greenkeeper informed me that the exact point of abstraction was unknown/inaccessible due to overgrowth (photograph 1). A pump for the system is located in a standalone building and is used to fill 2x 10,000l water tanks.

The licence allows the club to abstract for both spray irrigation and as a private water supply for domestic use in the clubhouse. I was informed that the borehole is not used as a private water supply currently. I was also informed that the borehole has not been used at all in 2024 due to the amount of rainfall meaning additional irrigation has not been needed. Records were provided to demonstrate this.

I checked the records for 2023 which showed that the borehole was used for irrigation from May-June only (photograph 2). This is within the period of abstraction allowed in (5) of the licence. A total of 600m³ was abstracted in 2023 which is <2,820m³ (the maximum yearly allowance). 20m³ is also the maximum abstracted in any one day which falls below the maximum daily allowance of

unknown/inaccessible.
