**Q3 Monitoring Returns**

The Q3 monitoring returns were received on 24th October 2024 for discharges from W2 emission point in compliance with permit condition 4.2.3.

Reported parameters were in compliance with the Emission Limit Values's (ELV's) defined in Schedule 3 (b) Table S3.2

**Q3 Waste Returns**

The Q3 waste returns were received on 24th October 2024 in compliance with permit condition 4.2.5. The waste returns were reviewed and no issues were found.
