4. Details of our assessment

On the 19th of September 2024 NRW received an early warning report from DCWW following a 'level rising' alarm at one of their assets. A Jetvan Crew Attended and confirmed a partial obstruction but that the sewer was running and not discharging to the river. DCWW checked the outfall to the river Taff at SO 03490 06780 and confirmed no

discharge to the watercourse at that present time. Contractors attended site but were unable to restore flows through the hydrobrake. On the 20th DCWW upgraded their report from an early warning to a self-report as levels had increased and the CSO had gone into a screened spill. DCWW set up over pumping which stopped the discharge to the river. On the 24th DCWW removed large quantities of wipes that were obstructing the hydro brake that controls the pass forward flow of the CSO chamber unblocking the sewer. **Incident confirmed as a partial obstruction of the flow control from a mass of wipes. No ammonia samples were taken due to lack of access.**

Breach of permit

Condition 2.3.1 (a) of the permit specifies that a discharge shall only occur when and only for as long as either:

a. The discharge shall only occur when and only for as long as either:

(i) the flow passed forward is equal to or greater than the overflow setting indicated due to rainfall and/or snow melt or

(ii) the hydraulic capacity of the sewer network downstream of the combined sewer overflow is reached due to rainfall and/or snow melt and the level of storm sewage in the sewer at the combined sewer overflow is greater than the weir level of the overflow structure which is specified as an overflow setting in table S3.3.

Actions taken by DCWW

1. Rodding / Lifting Hydrobrake Cable
2. **Overpumping**
3. CCTV
4. FOG Letters to be issued to large upstream catchment.
5. Reviewing maintenance , further jetting and possible alternative solutions to the current hydrobrake system
