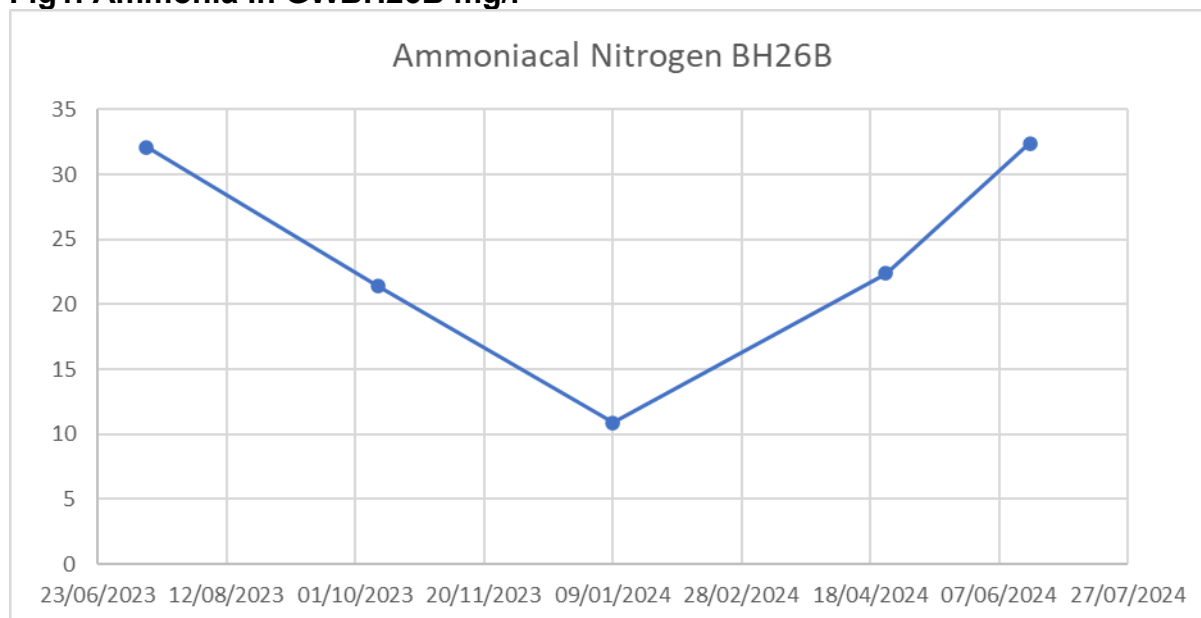
4. Details of our assessment

GROUNDWATER BOREHOLE AND SAMPLING - SITE INSPECTION

Ammonia In GWBH26B

GBWH26B, as shown in the graph below contains relatively high levels of ammonia. It is directly in line with the Llysfaen fault. This is a cause for concern but the borehole is not on the list of boreholes to be sampled in the permit and there is no apparent affect on the Dulas Valley Spring or the Dulas River itself.

An offsite borehole inspection was organised with Steve Croker of FCC and Initial Ltd. The borehole was located and bailed three times. The subsequent water was bottled for sampling.

It was noted that the water removed from the borehole had a distinct organic smell.

ACTION: It was agreed that although the sampling of this borehole is not a permit requirement, it should be continued as it is directly in line with the Llysfaen Fault.

ACTION: The results from the latest sample are to be submitted to NRW on receipt by FCC and a follow up meeting to be organised to assess the latest sample results and a way forward in terms of risk assessment and any additional actions.

CCS Scoring

There are currently no detectable effects on the water quality at the Dulas Valley spring or in the River Dulas. Therefore, it has been decided that, taking these aspects into account and the fact that the borehole is not referred to in the permit and all other sentinel

boreholes have very low levels of ammonia that no CCS score will be applied on this occasion.

2.11 Site protection and monitoring programme

2.11.1 The operator shall within 6 months of the issue of this Variation submit a Site Protection and Monitoring Programme.

2.11.2 The operator shall implement and maintain the Site Protection and Monitoring Programme in relation to all areas which will not comprise permanent deposits of waste and shall carry out and record a review of it at least every 4 years commencing from the date the Site Protection and Monitoring Programme was received.
