This Compliance Assessment Report (CAR) is an assessment of the 2024 Q3 reporting submission required by the permit of the operator, Cwm Environmental Limited - Nantycaws HCI Waste Transfer & Treatment Facility.

The Q3 monitoring returns has been submitted to NRW in full in the reporting window as required by condition 4.2.3 of the permit.

From a review of the information submitted, Surface water monitoring monitoring was undertaken, and the results were compliant with the stipulated emission limit required by permit condition 3 Emissions and monitoring.
