Schedule 4 – Emissions and monitoring

Table S4.1 Leachate level limits and monitoring requirements require leachate levels in monitoring wells below 2m.

The Schedule report of permit breach for leachate level in-well, detailed in self-reported table below dated 31-10-2024 at 3.48m, shows this is over the 2m permit limit. The score for this breach is a CCS3 minor breach.
