4. Details of our assessment

On Thursday the 24th of October 2024 Natural Resources Wales officers carried out a routine unannounced site inspection. The visit was carried out by Waste Regulation Officer Ian Thomas and Senior Waste regulation officer Steven White.

On arrival officers reported to the site office/weighbridge and checked the relevant paperwork and documents for the company. Waste Transfer Notes, EMS and permit all looked to be in order. Michael Scarfo met officers at the office, Michael confirmed his father Martin Scarfo was still the Technically Competent Manager (TCM) for the permit.



Officers were accompanied around the site by Michael Scarfo. The site was quite muddy which is expected considering the recent rainfall, the site is well contained with minimal run off, there was some small areas where water had pooled but not to excess. The site was busier than previous visits, waste brought in from Knauf was being processed, once this is treated it is returned to Knauf. The yard area looks to be well managed with areas allocated to certain customer requirements and processing. The shed allocated to general waste was in use and relatively busy.

The operation is still producing 6F2 and topsoil which is analysed and tested to determine quality. Officers requested particular Waste Transfer Notes relating to movements of waste and product to several local locations in the area. This is to establish quantities moved to these sites.

It was noted on site that there were several locations where gas bottles were found not secured. It is understood that some of these have been found in general waste collections.

Action: Please ensure any gas bottles are stored securely.

Prior to visiting the site, waste returns were checked. Quarter 2 is up to date with 25990 T received, and 206T sent out. Quarter 3 returns are due.
