## 4. Details of our assessment

Angharad Clark attended Gavin Griffiths Recycling on 18th October 2024. She met with Jake Stephens, Operations Director who showed her around the site. It was raining heavily and had been for some days. The permit, EMS, FPMP and site diary were readily available in the office. Whilst there was some mud evident on the roads inside the site, there was no evidence of it leaving site. A wheel-wash facility was present at the exit. Numerous silt lagoons and series of silt fencing were present along the back of the site. All appeared to be well maintained. The wash plant was operational with distinct grades being produced. Jake Stephens is taking over as TCM and will send us the relevant certification when he renews it. No issues.
