Officers Eleanor Davies and Gareth Davies attended site for a routine inspection and to carry out a handover as Eleanor Davies will be the regulating officer for your site moving forward.

We were met on site by Danny Reynolds who showed us around and explained the operations on site. The site was clean and the drainage channels were clear and in working order.

There was a large pile of mixed waste in the centre of the external yard area waiting to be processed. Danny Reynolds explained that this was about the maximum amount of waste they would have at any one time and that he expected the flow of waste in to site to slow down over the winter period and pick up again with the warmer weather.

All oils, lubricants and other waste liquids were clearly labelled and stored appropriately within the building.

At the time of inspection noise levels were as expected at an operational waste site. No recent noise complaints have been received by NRW with regards to Celtic Recycling's activities.
