4. Details of our assessment

This was an unannounced site inspection visit to check that fridge freezers brought to site are being stored correctly, in accordance with condition (h) of table 4.7 in the environmental permit (standards for handling and/or storage of waste with specified characteristics). These items are now stored inside a weatherproof shipping container on the site, which has an impermeable pavement and sealed drainage system. This arrangement would benefit from the addition of ventilation to the container, in order to prevent a build up of fumes should any gases or liquids escape from the waste items. Please ensure ventilation is provided.
